### **Changes to our Standard Conditions of Recognition**

Following our recent three-country consultation on a set of changes to our respective Conditions of Recognition, today we are announcing the decisions we have taken and analysis of the responses to that consultation.

All changes made to our Standard Conditions of Recognition will be implemented from 1 October 2020, with the exception of Condition H6.2 which comes into effect from March 2020. This particular Condition is designed to make it as clear as possible that we can intervene to secure a delay in an awarding organisation issuing results, and to allow us to do so quickly in the rare cases where it is necessary.

A copy of our [decisions report](#) and the [Standard Conditions of Recognition](#) that contains the changes that will come into force on 1 October 2020 have now been published. Alongside these documents, we have also published the [independent analysis of consultation responses](#) and a [summary of our engagement events](#).
