Sector qualifications update issue – May 2019



VOICE: new CBE qualification feedback surveys now open

Do you want to influence new qualifications in the construction and the built environment sector? Well, now's your chance.

A series of 'Voice' surveys, are now open to all stakeholders. It's your opportunity to look at the draft minimum requirements for each of the new CBE qualifications that are being developed and offer feedback.

Following our review of qualifications in the sector, we proceeded to develop the minimum requirements for eight new qualifications. September 2021 will see the introduction of a new GCSE in Built Environment and five new post-16 qualifications and in September 2022 a new AS/A level in Built Environment will be introduced. Our intention is for the qualifications to meet the needs of learners, centres and employers in Wales, as well as being highly portable across the UK.

We want stakeholders to look at the latest draft minimum requirements for these qualifications and answer a short feedback survey. This will help us make sure that the purpose of each qualification is clear and that the content and assessment arrangements are fit for purpose. It's also a chance for stakeholders to let us know what training and resource requirements centres might need to ensure the qualifications are delivered effectively.

Ein bwriad yw y bydd y cymwysterau yn diwallu anghenion dysgwyr, canolfannau a chyflogwyr yng Nghymru, yn ogystal â bod yn gludadwy ledled y DU.

Rydym am i randdeiliaid edrych ar y gofynion sylfaenol drafft diweddaraf ar gyfer y cymwysterau hyn ac ateb arolwg adborth byr. Bydd hyn yn ein helpu i sicrhau bod diben pob cymhwyster yn glir a bod y cynnwys a'r trefniadau asesu'n addas at y diben. Mae'n gyfle hefyd i randdeiliaid ein hysbysu o ofynion posibl canolfannau o ran hyfforddiant ac adnoddau er mwyn sicrhau y caiff y cymwysterau eu cyflwyno'n effeithiol.
