# 1 Introduction

This document sets out the Special Conditions which WJEC are required to comply with when Adapting assessments for GQ Qualifications in 2021/2022. These Conditions came into effect on 26 April 2021 and will remain in force until such date as specified or determined by Qualifications Wales.

For the purposes of these Conditions, the GQ Qualifications are as follows:

- Approved GCSE qualifications;
- Approved GCE Advanced Subsidiary (AS) qualifications;
- Approved GCE A level qualifications;
- Welsh Baccalaureate Skills Challenge Certificate (SCC), and
- Legacy GCSE, AS and A level qualifications which are only available to learners in Wales<sup>1</sup>.

With respect to all GQ Qualifications to which the Conditions set out in this document apply, save to the extent set out in those Conditions, WJEC must also comply with:

- our Standard Conditions of Recognition<sup>2</sup> which apply to all awarding bodies and qualifications, and
- all relevant Regulatory Documents<sup>3</sup>.

## 2 Special Conditions of Recognition – Adapting assessments for GQ Qualifications in 2021/2022

- SPCWJEC5.1** WJEC must consider whether or not it is necessary to Adapt assessments for GQ Qualifications which it makes available in winter 2021/22 and summer 2022, and make any such Adaptations required, in accordance with the principles and requirements set out in our document entitled 'Requirements for Adapting Assessments for GQ Qualifications (GCSE, GCE and Welsh Baccalaureate Skills Challenge Certificate) in 2021/2022'.
- SPCWJEC5.2** Where WJEC Adapts an assessment under Condition SPCWJEC5.1, it must ensure that it takes all reasonable steps to –
- (a) comply with the principles published by Qualifications Wales and revised from time to time, and
  - (b) only where there is a conflict between two or more of those principles, achieve a balance between those principles in line with any requirements published by Qualifications Wales and revised from time to time.
- SPCWJEC5.3** Where WJEC Adapts an assessment under Condition SPCWJEC5.1, it must ensure that it takes all reasonable steps to do so –
- (a) in compliance with any requirements, and
  - (b) having regard to any guidance which may be published by Qualifications Wales and revised from time to time.
- SPCWJEC5.4** Where WJEC Adapts an assessment under Condition SPCWJEC5.1, it must provide clear and accurate information about the Adaptations to Users of the qualification who are likely to be affected by those Adaptations.
